#### **REJECTION NOTICE**

# STAFF NURSE (POST CODE – 170/07)

In compliance of Orders of Hon'ble High Court of Delhi dated 13.05.2009 in the matter of Rashmi Dhara & Ors. Vs GNCT & Ors. (CWP No. 9114/2008) and other similar judgments in CWP No. 809/2009, 9139/2008, 181/2009 and 110/2009, vide which the Hon'ble High Court has held that "the petitioners who have received Diploma from Delhi Nursing Council is to be considered for appointment for the post of Staff Nurse. The petition filed by the petitioner who received diploma from Haryana Nurses Registration Council is devoid of any merit and is dismissed as the candidate had not even despite their being no training period of six months in their curriculum, did not get their final Marksheet before the cut off date of 21.01.2008". Hence not eligible.

The candidature of the following petitioners was examined to ascertain their eligibility for the post of Staff Nurse, Post Code-170/07 on the basis of the aforesaid direction of the Hon'ble High Court of Delhi. It is observed that the following candidates "had not even despite their being no training period of six months in their curriculum did not get their final Marksheet before the cut off date of 21.01.2008" and therefore do not satisfy the eligibility requirements for the post. The details are given as under:
