DOMESTIC SCIENCE TEACHER, POST CODE-92/17 IN DIRECTORATE OF EDUCATION.

The DSSSB vide its advertisement No. 04/2017 dated 22/12/2017 had advertised total 199 [UR-76 OBC-80, SC-27, ST-16, including PH (OH-03, VH-03)] vacancies for the post of **Domestic Science Teacher, Post Code-92/17 in Directorate of Education** with closing date as 31.01.2018. Tier-I examination in offline examination mode was conducted on 16/09/2018.

- 2. On the basis of online examination of Tier-1 held on 16.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of Domestic Science Teacher, Post Code-92/17 in Directorate of Education, a total of 58 (UR-37, OBC-05, SC-14, ST-02) candidates were provisionally nominated for the post of Domestic Science Teacher, Post Code-92/17 vide Result Notice No. 398 dated 03.04.2019 and the candidature of 25 candidates (UR-14, OBC-04, SC-06, ST-01including UR/PH/OH-02, VH-01) was kept pending for want of deficient documents / clarification and their documents were recalled w.e.f. 06.04.2019 to 15.04.2019.
- 3. Out of 25 pending candidates, 21 candidates have uploaded the requisite documents / during the period 06.04.2019 to 15.04.2019 and found eligible. 04 candidates are still kept pending for want of deficient documents.
- **4.** (i) Accordingly, in continuation to Result Notice **No.** 398 dated **03.04.2019**, the candidates, as detailed below, are also provisionally selected on the basis of offline examination of Tier-1 held on 16.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of **Domestic Science Teacher, Post Code-92/17** in Directorate of Education.

- 5. As per RRs, the essential qualification are prescribed (i) Bachelor's degree in Domestic Science/Home Science from a recognized University/Institute (ii) B.Ed. with Domestic Science/Home Science as a teaching subject. The candidates mentioned at Sl. No. 1, 5, 6 of para-4 (i) under UR category, Sl. No. 1 of para-4 (ii) under UR/PH (OH) category, Sl. No. 1 of para-4 (iii) under UR/PH (VH) category, Sl. No. 1 of para-4 (iv) under OBC category, Sl. No. 1,2,4, 5 of para-4 (v) under SC category & Sl. No. 1 of para-4 (vi) under ST category above having Bachelor degree and studied Home Science subject in all the three years. These candidates however, being nominated provisionally in contents of the decision of Hon'ble High Court in W.P.(C) No. 575/2013 in the matter of Directorate of Education and anr Vs. Neelam Rana with the request to the user department to check their eligibility conditions as per RRs. before issuance of any appointment letter. Further, the candidate bearing Roll No. 2710000351 mentioned at Sl. No. 3 of para-04 (v) under SC category have studied subject "Integrated Science" in place of Domestic Science/Home Science as a teaching subject in her B.Ed. degree. The user deptt. may take a final view regarding her eligibility prescribed in so far as essential qualification no. (ii) in RRs is concerned.
- 6. The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.
- 7. The user department shall also check the eligibility of the reservation benefit, if any. <u>Further, if applicable, User Department shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates.</u>
- 8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013.

- 9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and edossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 10. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 11. The candidature of the following candidates are being kept pending for want of deficient / requisite documents in the e-dossier. These candidates are being given 2nd & final opportunity w.e.f. 09/10/2019 to 15/10/2019 to upload the requisite documents:-
