SUPPLEMENTARY RESULT NOTICE NO: 908 TECHNICAL ASSISTANT (INTERIOR DESIGN), POST CODE-05/21 IN DEPARTMENT OF TRAINING AND TECHNICAL EDUCATION

The DSSSB vide its advertisement No. 01/21 dated 04/03/2021 had advertised 02 vacancies under UR category for the post of Technical Assistant (interior Design), Post Code – 05/21 in Department of Training & Technical Education. Online written examination for the post of was held on 16/11/2021.

- 2. On the basis of marks secured in the written examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post of Technical Assistant (Interior Design), Post code 05/21 and the terms and condition of the advertisement 01/21, two (02) candidates under UR Category were provisionally nominated for the post of Technical Assistant (Interior Design), Post Code-05/21 in Department of Training and Technical Education vide Result Notice No. 839 dated 01/04/2022.
- 3. Further, the User Department i.e. Department of Training & Technical Education vide letter dated 27/02/2023 has returned 02 dossiers under UR Category of the candidates who failed to join their duties in the User Department, after cancellation of their candidature and requested to provide 01 candidate under UR category from the waiting panel. As the waiting panel for the post code-05/21 was valid upto 31/03/2023 and the dossiers were returned before expiry of waiting panel, 01 candidate from waiting panel has been provisionally nominated.
- Accordingly, in continuation of Result Notice No. 839 dated 01/04/2022, the 4. candidates, as detailed below, are also provisionally nominated purely on the basis of marks obtained by the candidate in the basis of online examination of Tier-1 held on 16/11/2021 and also claims made by the candidate in their online application forms of the post code -05/21 for the post of Technical Assistant (Interior Design), Post Code-05/21 in Department of Training & Technical Education. The Board has not undertaken scrutiny of documents uploaded in the e-dossier at this stage, as per Board's resolution/decision dated 14/07/2022 & dated 20/02/2023. The eligibility as per Recruitment Rules and other terms and conditions as specified in the Advertisement No. 01/21 and relaxations as per rules in respect of educational qualifications, age, experience, etc. shall be scrutinized / verified by the User Department for determining eligibility of the candidates for the post code- 05/21 as on cutoff date 14/04/2021 before issuance of offer of appointment to the post:-

- 5. The provisional nomination of the above 01 candidate under UR Category is one the basis his/her claims in his/her application shall be subject to through verification of his/her candidature by the user department including the identity of the candidate as per Services Department circular No. F16(3)/2007/S-III/1756-1763 dated 02/08/2021.
- 6. The provisional nomination of the above 01 candidate under UR category shall further be subject to genuineness of the documents on the basis of which he has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of his identity with reference to his photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidate is liable to be cancelled by the User Department also, in case the candidate is found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 7. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 8. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidate is fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi)

certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

- 9. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 10. The User Department shall also get the EWS certificates verified from the Issuing authority. Further, the User Department shall also verify the veracity of the Income and asset certificate submitted by the candidate through the certificate issuing authority as per instruction of DoPT O.M. No. 36039/1/2019-Estt (Res) dated 31.01.2019.
- 11. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 12. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 13. The category wise marks obtained by the last selected candidate has been given as under:-

- 14. The result process for the above post code stands closed in all respect. Waiting panel was valid for a period of one year from the date of declaration of result i.e. upto 31/03/2023 as per Main Result Notice No. 839 dated 01/04/2022 which has been expired. The said result is declared against returned dossiers by the User Department which received in the Board well before expiry of waiting panel.
- 15. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
