SUPPLEMENTARY RESULT NOTICE NO. 1418
WARDER (MALE)
IN DELHI PRISON DEPARTMENT
POST CODE 37/2013

1. The DSSSB vide its advertisement No. 02/2013 with closing date 02/08/2013, had advertised 528 vacancies (UR-268, OBC-142, SC-79, ST-39 out of which 53 vacancies were reserved for EXSM) for the Post of Warder (Male) in Delhi Prison Department under post code 37/13.
2. Sh. Sunil Kumar (Roll No. 3713021824) could not qualify the Physical Endurance Test (PET) on scheduled date i.e. on 18.03.2015 as his height was measured less than the qualifying measurement i.e. 170 cms. as per Advertisement for the post of Warder (Male), under Post Code 37/13.
3. Sh. Sunil Kumar filed O.A. No. 40/2016 & O.A. No. 3932/2017 titled as Sunil Kumar Vs GNCTD & Ors. Ld. Tribunal vide its order dated 06.01.2022 in O.A. No. 3932/2017 had given following directions:

"15. In view of the aforesaid facts and circumstances, the present OA is disposed of with the following directions:-

(i) The respondents are directed to refer the matter of the applicant to an independent Government hospital to constitute a review medical board for the purpose of determining applicant's height only.

(ii) The respondents are further directed to intimate the applicant within two weeks from the date of receipt of a copy of this order about the date, time and venue for his medical examination, with not less than seven days' notice for this purpose;

(iii) It is made clear that in case the applicant is found fit otherwise for appointment, he shall be issued appointment letter to the post in question and he shall be entitled for all the benefits, including fixation of seniority and pay on notional basis from the date his immediate junior in the merit list was fixed, but he will not be entitled to arrears of pay.

(iv) The aforesaid exercise shall be completed within a period of two months from the date of receipt of a copy of this order.

16. The OA is disposed of in the aforesaid terms. However, in the facts and circumstances, there shall be no order as to costs."

4. The DSSSB filed W.P.(C) No. 7355/22 titled as GNCTD & Ors. Vs Sunil Kumar & Anr. against the said order of the Ld. Tribunal. The Hon'ble High Court vide its order dated 11/05/2022 had given following directions:-

"8. Without prejudice to the rights and contention of the parties, the respondent shall present himself before the Medical Superintendent of the said hospital on 18.05.2022 at 14:30 hours. The respondent's height will be measured in the presence of two doctors and a report shall be furnished to the Court before the next date by the Medical Superintendent of the said hospital. A representative of DSSSB too shall remain present on the said date at the time of the measurement of the respondent's height."

5. Therefore, a Medical Board was constituted in compliance of said order dated 11.05.2022 of Hon'ble High Court, at Govind Ballabh Pant Institute of Post Graduate Medical Education & Research (GIPMER). The Medical Board measured the Height of Sh. Sunil Kumar as 170.5 cms.

6. Subsequently Hon'ble High Court disposed of the W.P.(C) No. 7355/22 titled as GNCTD & Ors. Vs Sunil Kumar & Anr. with the following directions:-

"4. The requisite height for appointment is above 170 cm. Since the respondent's height has been measured as 170.5 cm. The respondent qualifies for the appointment.

5. Consequently, this petition is disposed of directing the petitioners to implement the order of the Tribunal dated 06.01.2022.

6. The petition is disposed of in the above terms. The pending application also stands disposed of."

7. Matter has been examined in compliance of above mentioned orders of Hon'ble High Court and it is found that as per record, Sh. Sunil Kumar (3713021824) had qualified rest of requirement of the Physical Endurance Test (i.e. 1600 meters race in 06 minutes, 13 feet Long Jump, 3.9 Feet High Jump and Chest measurement Test) on the date of PET i.e. on 18.03.2015. Further, the Medical Board measured the Height of Sh. Sunil Kumar as 170.5 cms., on 11.07.2022. Therefore, Sh. Sunil Kumar (3713021824) has declared as qualified in the Physical Endurance Test



vide Notice No. 1410 dated 26/08/2022 for the post of Warder (Male), under Post Code 37/13) in Delhi Prison Department.

8. Based on the performance in the written examination and being qualified in PET, the candidate Sh. Sunil Kumar having roll no. 3713021824 was provisionally shortlisted and accordingly allowed vide Notice No. 1410 dated 26/08/2022 to upload e-dossier from 06/09/2022 to 20/09/2022 subject to attaining minimum qualifying marks and correctness of the information furnished by the candidate in his online application form.
9. The result has been processed purely on the basis of marks obtained by the candidates in the examination held on 02.03.2014, qualified in PET and also claims made by the candidates in their online application forms of the post code 37/13 for the post of Warder (Male) in Prison Department, Govt. of NCT of Delhi. The Board has not undertaken scrutiny of documents uploaded in the e-dossiers and other terms and conditions of recruitment notified by the Board in the advertisement of the said post code at this stage, as per the Board's resolution dated 14/07/2022. The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement no. 02/2013 and relaxations as per rules in respect of educational qualifications, experience, etc. shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the post code 37/13 as on cutoff date 02/08/2013 before issuance of offer of appointment to the post.
10. Accordingly, the following candidate is provisionally nominated to the post of Warder (Male) as per their merit, subject to satisfaction in regard to any defect or deformity (including bow legged, knocked knees, flat feet, etc.) to be checked by the User Department which would render candidate ineligible for recruitment as per the requirement of the RRs:-

11. Ld. Tribunal vide its interim order dated 07/04/2015 in OA No. 1294/2015 in the matter of Varun Sharma V/s GNCTD has directed to keep one post pending, accordingly one post of UR category is kept as pending.
12. The provisional nomination of the above 01 candidate (OBC-01) shall be further subject to thorough verification of candidature of the candidate by the User Department including the identity of the candidate.



13. The provisional nomination of the above 01 candidate (OBC-01) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the User Department in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
14. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Delhi Prison Department, Govt. of NCT of Delhi shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally nominated candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
15. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
16. The User Department shall also get the SC/ST/OBC/EWS/PH certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt.




(SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/1/2013-Estt. (Res) dated 27/05/2013 and 13/09/2017 and other instructions/guidelines issued from time to time by the competent authorities.

17. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide **MHA OM No. 2/29/54-RPS, 19/11/54.**
18. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
19. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
20. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
21. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
22. The category wise marks scored by the last candidate provisionally nominated are as under:-

23. The recruitment process for the Post of Warder (Male) under Post Code 37/13 has already been closed. Further, the validity for Wait List panel was expired on 08/07/2019.
