DRAWING TEACHER, POST CODE-91/17 IN DIRECTORATE OF EDUCATION.

The DSSSB vide advertisement No. 04/17 had advertised **295 vacancies (UR-105, OBC-122, SC-48, ST-20 including OH-05, VH-04)** for the post of **Drawing Teacher, Post Code-91/17 in DOE** vide advertisement No. 04/17. The Board had conducted online written examination to the above post code on 29.09.2018.

- 2. On the basis of offline examination of Tier-1 held on 29.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of Drawing Teacher, Post Code-91/17 in Directorate of Education, a total of 165 (UR-93, OBC-15, SC-42, ST-15 including 03 PH) candidates were provisionally nominated for the post of Drawing Teacher, Post Code-91/17 vide Result Notice No. 443 dated 27.05.2019 and the candidature of 19 candidates (UR-08, OBC-05, SC-06) was kept pending for want of deficient documents / and their e-dossiers were recalled w.e.f. 29.05.2019 to 07.06.2019. Further, 11 candidates (UR-03, OBC-03, SC-05 including 01 PH) were nominated vide Supplementary Result notice No. 617 dated 16.03.2020 and 07 candidates were kept pending for want of deficient documents in the e-dossier and 01 candidate was rejected who was kept pending earlier. The pending candidates were given 2nd and final opportunity w.e.f. 18.03.2020 to 25.03.2020.
- 3. Now, the User Department vide letter dated 26/12/2019 has returned the dossiers of 18 candidates (UR-12, SC-04, ST-02 including 01 PH/OH) after cancellation of their candidature for not appeared for documents verification in the User Department. Accordingly, 18 vacancies under (UR-12, SC-04, ST-02 including PH/OH) have become unfilled. Therefore, the candidates from waiting panel are considered for nomination below the last selected candidate in their respective categories.
- 4. (i) Accordingly, in continuation to Result Notice No. 443 dated 27.05.2019, Supplementary Result Notice No. 617 dated 16.03.2020, the candidates, as detailed below, are also provisionally selected on the basis of offline examination of Tier-1 held on 29/09/2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of Drawing Teacher, Post Code-91/17 in Directorate of Education.

- 5. * The candidate bearing Roll No. 111009100160 has uploaded a certificate of 5th year Ankan Bivakar in painting from Bangiya Sangeet Parishad which is affiliated to Rabindra Bharti University for Junior Vocal Section and diploma awarded by Bangiya Sangeet Parishad recognized by Govt. of Assam & Indira Kala Sangeet Vishwa Vidyalaya, Khairagarh, M.P. As per RRs. Five year diploma in Drawing/Painting/Sculpture/Graphic Art from a University/Institute recognized by Govt. of India. As the Board has no expertise to ascertain the recognition of the institute/University, the candidate provisionally nominated for the post of Drawing Teacher, Post Code-91/17 with the request to the User Department to thoroughly examine the education qualification of the candidate before issuance of any appointment letter. If, the candidate found not eligible, his e-dossier may be returned to the Board after cancellation of his candidature.
- The selection of the above 03 candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 8. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various

Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

- 9. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 10. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 11. The user department shall ensure that the appointment made is in conformity with DoPT quidelines and instructions of Govt. issued from time to time.
- 11. Further, the candidature of following 01 candidate is being kept pending for want of deficient /requisite documents in the e-dossier as per details given below:-

- 12. The candidate bearing roll No. 110709100004 is being given 1st opportunity to upload the deficient /requisite documents in the e-dossier w.e.f. 29/09/2020 to 08/10/2020, failing which her candidature will be rejected and no further opportunity will be given on whatsoever ground.
- 13. The e-dossier link shall be activated for the candidates w.e.f. 29/09/2020 to 08/10/2020.
- **14.** The result process for the above post code stands closed in all respect except pending candidates.
- **15.** Waiting panel which was valid for a period of one year from the date of declaration of result i.e. upto 26.05.2020 as per earlier **result notice no. 443 dated 27.05.2019**.
- 16. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
