The candidature of Ms. Manju Yadav Roll No.15910558 who was erroneously selected vide order no F1/154/CC II/2008/328-331 dated 27/10/08 for the post of Domestic Science Teacher under OBC Category is hereby rescind, as at the time of forwarding of dossiers the facts about her not possession of OBC Certificate issued by the authorities of GNCTD came into notice which is a prerequisite condition for admissibility of benefit of reservation in OBC category. In UR Category her marks are less then the marks secured by the last selected UR candidate.

The recommendation for appointment to the post of TGT of above 16 (UR-03; OBC-04; SC-03, ST-04) candidates is being made on the basis of information and documents furnished by the candidates in their application forms. The appointing Authority of the user Department shall verify and satisfy if self about the authenticity of documents and eligibility as per the RRs before appointing the candidates. Therefore the provisional selection of a candidate confers him/her no right of appointment unless the Appointing Authority is satisfied after scrutiny of documents, about suitability of the candidate for appointment to the post.
