The present notice is in continuation to result notice dated 16.10.2008, 15.12.2008, 11.2.2009, 1.4.2009, 12.5.2009 and 13.11.2009. Since the result in respect of the advertised vacancies under post 110/06 and 111/06 had already been declared and nomination made to the Directorate of Education as per Directorate's clarification on elective issue vide letter no. DL 3(199)/E-III/2005/20517 dated 13.8.2007, as such to facilitate the Directorate in implementing the orders of Hon'ble CAT, in result notice the merit position of the candidate of the candidate in his category has also been indicated. The candidature of the candidates is liable to be cancelled by the user Department also, in case the candidate is not found fulfilling the eligibility conditions or any other genuine reasons. The competent authority of the user Department shall arrange to verify the correctness of information/documents as furnished in the application form after verification of the same from original documents/issuing authority. Mere inclusion of name in the result notice does not confer any right upon the candidates over the post.

The selection/appointment of above mentioned candidate shall further be subject to outcome of any other court cases in the matter.
