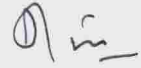

It is further clarified that the eligibility regarding knowledge of Hindi/ working knowledge of Hindi has not been checked by the DSSSB due to late instructions issued in this regard by the User Department and the same, therefore, should be ensured by the User Department before issuance of appointment letter.

Further, roll no. mentioned at Sl. No. 2 in SC category above stand deleted from the rejection notice no. 37 dated 24/06/2016 on finding him eligible after receiving clarifications on the issue related to the reason for rejection.
