Reference Notice No. F. No. 291/Result/T.A(Computer)/CC-III/DSSSB/2021-22/3316-24 dated 23/12/2022, the shortlisted candidates for the post of Technical Assistant(Computer), post code-115/20 were asked to upload their documents in the e-dossier w.e.f. 28/12/2022 to 11/01/2022.

2. Further, 20 Candidates failed with deficient documents, were given 1st opportunity **w.e.f. 04/02/2022 to 13/02/2022** to upload the deficient /requisite documents. However, out of 20 candidates 15 Candidate have not uploaded the requisite documents. Therefore these 15 Candidates are given 2nd & final opportunity w.e.f.15/03/2022 to 19/03/2022, finally which their candidature will be rejected and no further opportunity will be given on whatsoever ground.

3. The above 15 candidates are being given 2nd opportunity w.e.f. 15/03/2022 to 19/03/2022 to upload the deficient /requisite documents in the e-dossier, failing which their candidature will be

rejected and no further opportunity will be given on whatsoever ground.

4. The e-dossier link shall be activated to the above 15 pending candidates only for a period of 05 days w.e.f. 15/03/2022 to 19/03/2022.

5. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e **27/02/2020** as per Advertisement No. 05/2020.

6. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her deficient documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
