ORDER

This order shall dispose of the representation dated 09/07/2021 filed by Ms. Vandana (Roll No. 11211500031), candidate for the post of Assistant Teacher (Nursery), Post Code-16/19.

- 2. The candidate Ms. Vandana (Roll No. 11211500031) applied for the post of Assistant Teacher (Nursery) under Post Code-16/19 under OBC category and appeared in the computer based online examination on 19.11.2019 and scored 86.50 marks out of 200 marks. The Candidate was shortlisted for uploading of all the relevant documents in the edossier with regard to Educational/Professional Certificates/Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards etc., as applicable in the E-dossier module in OARS link in his/her individual account in OARS module w.e.f. 30.06.2020 to 14.07.2020 (15 days) vide Notice No. F. No. 236/Result/Asstt. Teacher (Nursery)/Int. Cell/DSSSB/2019-20/1636-44 dated 22/06/2020 on the Board's website i.e. www.dsssb.delhi.gov.in.
- 3. That on scrutiny of the documents uploaded in the e-dossier by Ms. Vandana (Roll No. 11211500031), it has been found that the candidate has mentioned/filled her caste category classification as OBC certificate No. 90509681196888 date of issue 20.01.2018 issued by Tehsildar Kapashera, South West District, New Delhi but she has uploaded OBC certificate issued vide No. OBC/09/93/27269/22/06/2012/9631093294 dated 10.08.2012 which was issued to the candidate on the basis of her father resident District Ambedkar Nagar, Uttar Pradesh who belongs to Kahar caste. The details of OBC certificate mentioned in the e-dossier verification report are totally different with OBC certificate uploaded by the candidate in the e-dossier. However, OBC certificate dated 10.08.2012 which was issued on the basis of her father resident of Uttar Pradesh uploaded by the candidate is meant for OBC (outsider) and her candidature is considered under UR category.
- 4. That the result for the post of Assistant Teacher (Nursery), Post Code-16/19 was declared vide Result Notice No. 706 dated 19.11.2020 and the candidature of Ms. Vandana (Roll No. 11211500031) was not in consideration zone neither under UR category nor OBC category for being lower in merit. Accordingly, her e-dossier was not recalled.

- 5. Further, when the merit in each category became lower, she was given 10 days 1st opportunity w.e.f. 25.05.2021 to 03.06.2021 to upload 'OBC (Delhi) certificate vide which her caste is recognized as backward class under Govt. of Delhi' vide Notice No. F. No. 236/Result/Asstt. Teacher (Nursery)/Int. Cell/DSSSB/2019-20/1495-1503 dated 17/05/2021. The candidate was also informed through SMS as an additional facility to upload the deficient documents in the e-dossier on her mobile no. 9910662876 registered with OARS module of DSSSB.
- 6. That even after giving 10 days 1st opportunity w.e.f. 25.05.2021 to 03.06.2021, it was found that Ms. Vandana failed to upload OBC (Delhi) certificate in the e-dossier. Accordingly, she was given 05 days, 2nd and final opportunity w.e.f. 15.06.2021 to 19.06.2021 to upload 'OBC (Delhi) certificate vide which her caste is recognized as backward class under Govt. of Delhi' vide Notice No. F. No. 236/Result/Asstt. Teacher (Nursery)/Int. Cell/DSSSB/2019-20/1581-90 dated 10/06/2021.
- 7. That the candidate Ms. Vandana (Roll No. 11211500031) has submitted representation dated 09.07.2021 annexed herewith one more OBC certificate issued vide No. 90500000749068 dated 10.06.2021 and stated that portal was not active due to this she could not upload the documents and requested to accept the same offline.
- 8. That the representation dated 09.07.2021 of the candidate has been examined in details and found that the details of OBC certificate enclosed with representation dated 09.07.2021 are totally different with the details mentioned in OARS e-dossier verification report & uploaded OBC certificate. Further, as per policy of the Board, the candidate was given two sufficient opportunities to upload the OBC (Delhi) certificate but failed to upload the same. She also failed to obtain OBC (Delhi) certificate issued prior to cutoff date for the post.
- 9. Further, apart from the above, all the candidates who applied for the post of Assistant Teacher (Nursery), Post Code-16/19, before submission of application, submitted the following declaration:-
- I. The candidate has undertaken that:- (a) "I hereby certify that all statement made in this application are true, complete and correct to the best of my knowledge and belief and have been filled by me".
- If the candidate has undertaken that:- (c) "I have read all the provisions mentioned in the advertisement/notice of examination carefully as published in the website of DSSB and I hereby undertake to abide by them.
- III. The candidate has undertaken that:- (d) "I understand that in the event of information being found false or incorrect at any stage prescribed in the notice or any ineligibility being detected before or after the examination, my

- candidature/selection/appointment is liable to be cancelled/terminated automatically without any notice to me and action can be taken against me by the DSSSB.
- IV. The candidate has undertaken that:- (e) " the information submitted herein shall be treated as final in respect of my candidature for the post applied for through this application form.
- 10. Therefore, after considering the representation dated 09.07.2021 of Ms. Vandana (Roll No. 11211500031), the candidature of the candidate is rejected for the post of Assistant Teacher (Nursery), Post Code-16/19 under OBC (D) category for not uploading of OBC (Delhi) certificate which should have been issued to her prior to the cutoff date of the post in the e-dossier even after two opportunities were given by DSSSB. However, her candidature is still alive under UR category but not in consideration zone at present.
- 11. This issues with the approval of Competent Authority, DSSSB.
