RESULT NOTICE NO:1214 POST OF DISTRICT STAFF OFFICER UNDER POST CODE 70/12 IN DIRECTORATE OF HOME GUARD & CIVIL DEFENCE

- The DSSSB vide its advertisement No. 02/12 had advertised 01 vacancy (UR-01) for the Post of District Staff Officer under Post Code 70/12 in Directorate of Home Guard & Civil Defence.
- 2. Tier –I offline examination was held on 24.11.2019. Further, the result of Tier- I examination was declared vide result notice no 1020 dated 05.02.2020. As per the new exam policy dated 14.02.2013, Tier-II(T) examination was held on 23.02.2020 and marks obtained by the 08 candidates who duly appeared in Tier-II (T) examination conducted offline mode on 23.02.2020 have been uploaded in OARS module.
- 3. Further, vide Notice No. 1181 dated 15.09.2020, e-dossiers were called w.e.f. 18.09.2020 to 02.10.2020 and vide Notice no 1207 dated 20.10.2020 the candidature of one candidate (UR-01) was kept pending for want of deficient document required as per RRs and the deficient documents were recalled (1st recall) through OARS module, during the period 27.10.2020 to 05.11.2020.
- 4. The result has been processed keeping in view of the eligibility conditions and relaxation thereof in respect of educational qualifications etc. as on cut off date i.e. 15.06.2012 for the post code 70/12.
- 5. On the basis of marks secured in written examination and after preliminary scrutiny, as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions as stipulated in the advertisement the candidature of the following candidate total-01 (UR-01) provisionally selected for the post of District Staff Officer in Directorate of Home Guards and Civil Defence under post code 70/12 subject to fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidate in the online application form and e-dossiers:-

*Note- That as per RRs one of the essential qualification is

"Training in Instructor Course in Rescue and Fire Fighting OR

Ability to impart training in any four of the following in English or Hindi:

(a) Drill (b) Arms Drill (c) Weapons Training (d) Company Drill (e) First Aid (f) Rescue (g) Ambulance with Special knowledge of working and operation of Control Centre."

Further, the same is a subjective and technical matter and user department has not provided any specification in this regard, therefore, at this stage, DSSB has not undertaken the veracity/scrutiny of experience certificate furnished by the candidates as such user department i.e. DHGCD is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the proposed candidate. The selection is provisional and subject to the satisfaction of user department regarding experience certificate furnished by above candidates.

- 6. The provisional selection of the above total one candidate (UR-01) shall be further subject to genuineness of the documents on the basis of which he/she has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of his identity with reference to their photographs, signatures/ handwriting etc. On the application form, admission certificate etc. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the posts or for any other genuine reason. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate. The Competent Authority of the Department concerned shall issue the offer of appointment to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, age and other essential certificates.
- 7. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. The user Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.



- 8. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidates in the light of Notification No. 36012/22/93-Esttt.(SCT)dated 08/09/1993 issued by DOPT and other instructions/ guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the user department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC(Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Deptt, GNCTD after thorough verification of caste certificate.
- 9. User Department shall also get the SC/ST/OBC certificates verified from the issuing authority. Further, in case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DOPT O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14/10/2008 and 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 10. The Competent Authority of the Department concerned shall issue the offer of appointment to the candidates after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates including caste certificate as per Government of India instructions issued in this regard vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 11. The User department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt issued from time to time.
- 12. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 13. The recruitment process for the said post code i.e.70/12 has been closed subject to disposal of pending cases.
- 14. The Select panel/Waiting List for the post code 70/12 has been maintained in respect of UR category and the same shall be valid upto 22.11.2021
- 15. The above result is subject to outcome of pending court case and other cases, if any.
- 16. The marks of last provisionally nominated candidates in following categories, after this result, are as follows:-
