SUPPLEMENTARY RESULT NOTICE NO. 720
ASSISTANT TEACHER (NURSERY), POST CODE-88/17
IN DIRECTORATE OF EDUCATION

The DSSSB vide its advertisement No.04/2017 dated 20/12/2017 had advertised total 320 vacancies (UR-164, OBC-88, SC-42 & ST-26 (including PH/OH-05 & PH/VH-05) for the post of **Assistant Teacher (Nursery) under Post code-88/17** in Directorate of Education with closing date as 31.01.2018. Tier-I examination in online computer based examination mode was conducted on **02.09.2018**.

2. On the basis of online examination of Tier-1 held on **02.09.2018** and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of Assistant Teacher(Nursery), Post Code-88/17 in Directorate of Education, a total of **173 candidates (UR-90, OBC-34, SC-40, ST-09, PH/OH-04, PH/VH-01), 08 candidates (UR-03, OBC-04 & ST-01), 05 candidates (UR-02, SC-02 & ST-01)** and **01 candidate (SC-01)** were provisionally nominated vide **Result Notice No.442 dated 24/05/2019, Supplementary result notice no. 539 dated 31.10.2019, Supplementary Result Notice No. 570 dated 23.12.2019** and **Supplementary Result Notice No. 607 dated 27.02.2020** respectively for the post of Asstt. Teacher(Nursery), Post Code-88/17.

3. Further, user department i.e. Directorate of Education vide letter dated 28/02/2019 and 06/03/2020 had returned 30 dossiers (**UR-21, OBC-04, SC-04 & UR(PH/OH)-01**) of the candidates with the request to provide substitute from waiting panel. As the waiting panel in this post code is available only under SC category which was valid upto 23.05.2020, there were only 04 candidates available under waiting panel of SC category and out of them two candidates had already been nominated. Accordingly, 02 candidates (SC-02) from the waiting panel below the last selected candidate has been nominated vide **Supplementary Result Notice No.691 dated 12.10.2020** but 02 vacancies (SC-02) could not be filled up even after considering all the shortlisted candidates of waiting panel under SC category. The said dossiers had been received before expiry of waiting panel and qualified candidates were still available in SC category. Therefore, to fill up the remaining 02 vacancies in SC category, the e- dossiers of the 08 qualified candidates which are available immediately below the last shortlisted candidate under SC category were called vide Notice dated 13.10.2020. Out of these 08 candidates, only 03 candidates successfully uploaded their e dossier and 05 candidates failed to upload the same in stipulated time. Accordingly, the candidature of 05 candidates (SC-05) is being rejected and out of 03 candidates, 02 candidates (SC-02) are considered for nomination as per their merit for the post of **Asstt. Teacher (Nursery), Post Code-88/17**.

4. Accordingly, in continuation to Result Notice No. **442** dated **24/05/2019**, Supplementary result notice No. **539** dated **31.10.2019**, Supplementary Result Notice No. **570** dated **23.12.2019**, supplementary Result Notice No. **527** dated **03.10.2019**, **Supplementary Result Notice No. 607 dated 27.02.2020** and **Supplementary Result Notice No. 691 dated 12.10.2020** the candidates detailed below are also provisionally selected on the basis of online examination of Tier-I held on 02.09.2018 and having been found provisionally eligible as per

documents uploaded in support of educational qualification etc. in accordance with advertisement No.04/2017 and RRs for the post of **Asstt. Teacher (Nursery)**, Post Code-88/17.

5. The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. **The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.**

6. The user department shall also check the eligibility of the reservation benefit, if any. **Further, if applicable, the User Department i.e. Directorate of Education shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.**

7. **It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.**

8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, **DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2008, O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.**

9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide **MHA O.M. No. 2/29/54-RPS, 19-11-54.**

10. The user department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.

11. The result process for the above post code stands closed in all respect except pending court cases, if any.

12. Further, as per result notice no. 442 dated 24/05/2019 wait list panel for the post code 88/17 (available only in SC category) was valid for a period of one year, i.e. up to 23.05.2020.

13. The category-wise marks obtained by the last provisionally nominated candidates are as under:-
