SUPPLEMENTARY RESULT NOTICE NO. 718 PGT (History), MALE POST CODE-112/17 IN DIRECTORATE OF EDUCATION

DSSSB vide its advertisement No.04/2017 dated 20/12/2017 had advertised total **92 vacancies (UR-47, OBC-25, SC-12 & ST-08 including 02 PH)** for the post of PGT (History) Male under Post code-112/17 in Directorate of Education with closing date as 31.01.2018. Tier-I examination in online computer based examination mode was conducted on 05.07.2018.

- On the basis of online examination of Tier-1 held on 05.07.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the Post Code-112/17 in Directorate of Education, a total of 63 candidates (UR-34, OBC-11, SC-11, ST-07 including PH-01), and **26 candidates** (UR-10, OBC-14, SC-01, ST-01 including 02 PH) were provisionally nominated vide Result Notice No. 319 dated 19/12/2018 and Supplementary Result Notice No.482 dated 12/07/2019 respectively. Further, 04 candidates (UR-02, SC-02 nominated vide candidates (UR-02) were also including 01-PH)and 02 24/02/2020 dated No.603 Result Notice Supplementary Supplementary Result Notice No.692 dated 19/10/2020 in lieu of the dossier returned by user department.
- 3. The candidature of **03 candidates** (UR-01, OBC-01 & ST-01) was also kept pending vide **Supplementary Result Notice No.692 dated 19/10/2020** for want of deficient documents in their e-dossier. Out of these 03 pending candidates, 01 candidate failed to upload the requisite the document in stipulated time and 01 candidate was found not eligible on the basis of document uploaded by him. Accordingly, the candidature of 01 candidate (ST-01) is being rejected, however, the candidature of 01 pending candidate (OBC-01) is still being kept pending for giving him 2nd and final opportunity to upload the requisite document in his edossier. Accordingly, the candidate available in waiting panel below the last selected candidate in ST category has been considered for nomination for the post of **PGT (History) Male under Post code-112/17**.
- 4. Accordingly, in continuation to Result Notice No.319 dated 19/12/2018, Supplementary Result Notice No.482 dated 12/07/2019, Supplementary Result Notice No.603 dated 24/02/2020 and Supplementary Result Notice No.692 dated 19/10/2020 the candidates detailed below (UR-01, ST-01) are also provisionally selected on the basis of online examination of Tier-I held on 05.07.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification etc. in accordance with advertisement No.04/2017 and RRs for the post of PGT (History) Male Post Code-112/17.

- 5. The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 6. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Directorate of Education shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 7. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification

- No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2008, O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 10. The user department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 11. The candidature of the following candidate is being kept pending for want of deficient/requisite documents in the e-dossier. The said candidate is being 2nd and final opportunity w.e.f. 02/12/2020 to 06/12/2020 to upload the requisite documents:

The link shall be activated for the above pending candidate w.e.f. 02/12/2020 to 06/12/2020 The above said candidate is directed to upload above document in his e-dossier during the stipulated time, failing which his candidature will be rejected and no further opportunity will be given on what so ever ground.

- 13. The recruitment process for the post Code-112/17 stands closed in all respect except 01 pending candidate.
- **14.** Further, as per Result Notice No.**319** dated **19.12.2018** wait list/panel for the post code 112/17 was valid for a period of one year, i.e. upto 18.12.2019.

- * Kindly note at sub para -vii of para-2 (Mode of Selection) in the Advertisement No. 04/17, that "If there are two or more candidates in the same category having equal marks in the examination, the candidate older in age will get preference" in case of further tie, candidate having higher marks in Section "A" of the test shall be preferred.
